# Judge Recruitment Information

It has become more difficult each year to get judges for the show. There have also been complaints about various judges over the years. However, when it becomes a choice of a judge we may not prefer or no judge we are left with few options. In an effort to expand our options, we are continuing the judge recruitment process implemented last year. Any 4-H Dog project member or leader or County Extension Agent may recruit judges for the 2016 Texas 4-H Dog Show, July 8-10, 2016 in Belton, Texas.

The process will be as follows:

Members, leaders and County Extension Agents recruit potential Dog Show Judges who are experienced in the events we offer.

Get a commitment from them that they are willing to hold the date until confirmation.

Submit completed recruitment form to Kristy Titzman, County Extension Agent – 4-H Youth Development, Walker County by April 29, 2016

Candidates will be evaluated and selected based on availability and skill level

Those selected will be contacted on or before May 20<sup>th</sup> for confirmation and those not selected will be contacted so they can release the date.

As in the past the confirmed judges will not be announced until the program is distributed at the show.

This form will be submitted to Kristy Titzman by March 31, 2016. Selections and notifications will be made by May 20, 2016

The 2016 Texas 4-H Dog Show will be held July 8-10, 2016 at the Bell County Expo in Belton, Texas. We have an average of 100 handlers and 120 dogs. 4-H members are 8 to 18 years old with varying degrees of skill and quality of dogs, registered and mixed breed. Most of our classes are divided into three age divisions: 3<sup>rd</sup> – 5<sup>th</sup> grade are Juniors, 6<sup>th</sup> – 8<sup>th</sup> grade are Intermediate and 9<sup>th</sup> – 12<sup>th</sup> grade are Seniors. Lower skill level classes are larger than the higher skill levels. We are able to provide a \$50 stipend to each of our judges and will provide meals during the show as needed.
